SECTION 4: FIRST AID MEASURES

6.3. Methods and Materials for Containment and Cleaning Up

For Containment: Contain solid spills with appropriate barriers to prevent migration.

Methods for Cleaning Up: Clean up spills immediately and dispose of waste safely. Recover the product by vacuuming, shoveling or sweeping. Transfer spilled material to a suitable container for disposal. Vacuum clean-up is preferred. If sweeping is required use a dust suppressant (water). Contact competent authorities after a spill.
